Superintendent Tieman gave the Elementary, Middle, and High School report for the building principals since there was no student attendance to report. Superintendent Tieman thanked the principals for their work to get ready for school, the custodians for their great effort to get the buildings ready, and thanked the secretaries for also getting everything ready for school.

Superintendent Tieman discussed the plans that he, Principal Rosentreter, and the architect have been working on for the proposed new Gillespie Middle School Science Lab. The three middle school science teachers also gave input in the preliminary plans. He distributed the preliminary drawings. Superintendent Tieman did stress that the plans were in the infancy stage and funding for the project is not in place yet. There is interest from *The Partnership for Educational Excellence* and Boeing to help with the funding of the technology of the project. This science lab project would include Robotics, STEM (Science Technology Engineering Math), lab, and classroom. (STEM is required by Common Core.) The plans are to use 3 consecutive classrooms in the north hall of the Middle School Building adding some expansion into the hallway. Rooms would be equipped with dividers to allow more than one science class to utilize the rooms at the same time.

Superintendent Tieman announced a "Fix The Formula Town Hall" Meeting to be held Thursday, July 27, 2017 from 6:00-7:30 p.m. in the Gillespie High School Gymnasium at 612 Broadway St., Gillespie, IL. The meeting will be hosted by Superintendent Joe Tieman, Superintendent Dan Cox, and Superintendent Brad Skertich, also featuring Senator Andy Manar, Representative Christian Mitchell, and Comptroller Susana Mendoza. This Town Hall Meeting is to learn the facts about school funding reform.
